SHOULD THIS ELECTION BE CERTIFIED?
 Chester County Commissioners at the November 17 Board of Elections hearing decided to count unlawful votes, setting a precedent citing voter intent as grounds to usurp the law.

- CC Republican Committee challenged over 1,000 provisional ballots with various problems involving lack of voter signatures and/or poll worker signatures.
- Some ballots lacked secrecy envelopes, were in different envelopes, or were unsealed.
- Some Judge of Elections allowed voters not appearing in the poll books to cast regular ballots without proper ID.
- Guidance was incorrect, inconsistent between various precincts, or unavailable due to poll workers not being able to reach voter services.
- High turnover among election officials resulted in inexperience and poor training.
- Inconsistent messaging about the time for shutting down tabulators and that votes after 8 pm had to be with provisional ballots.
